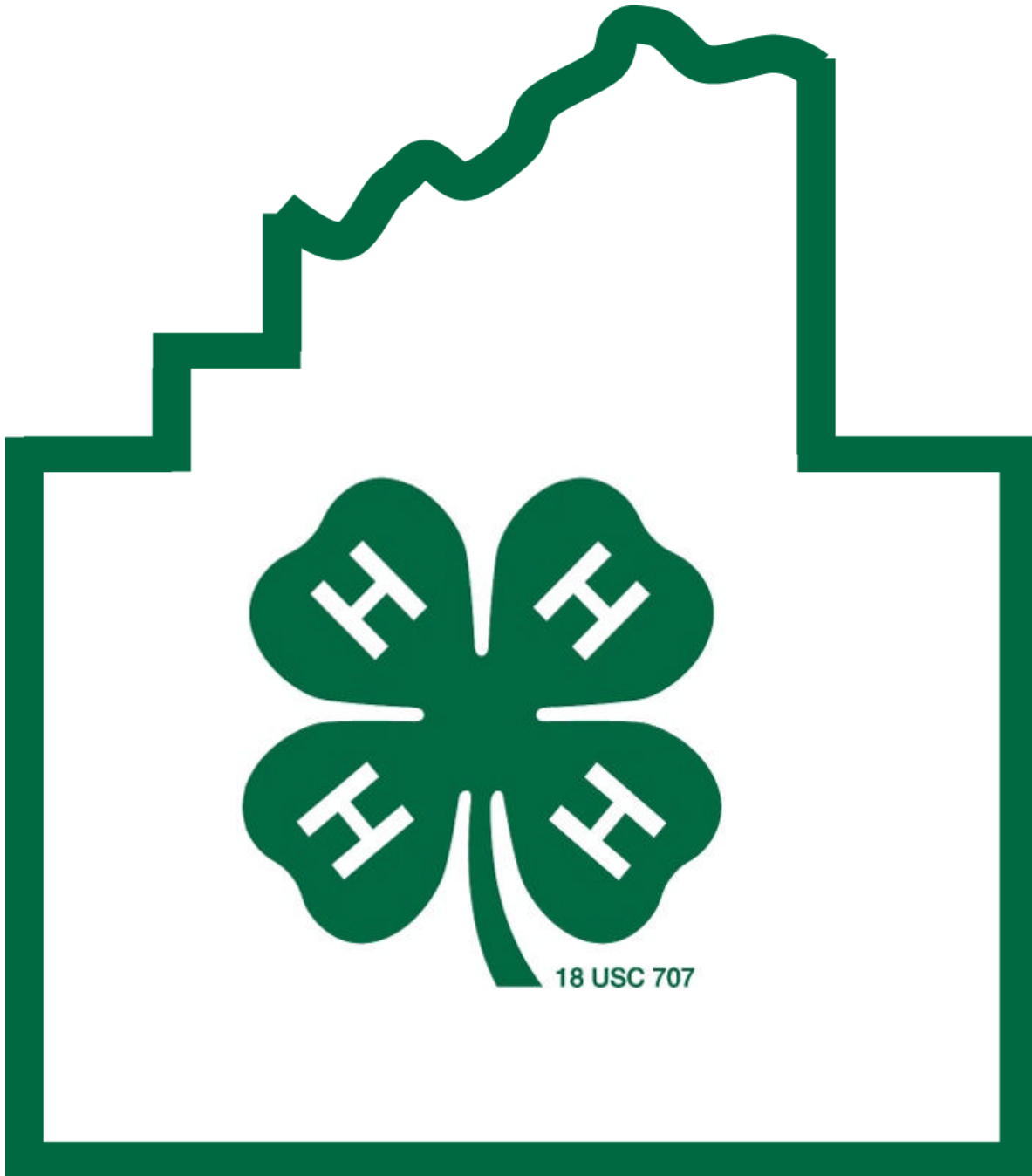

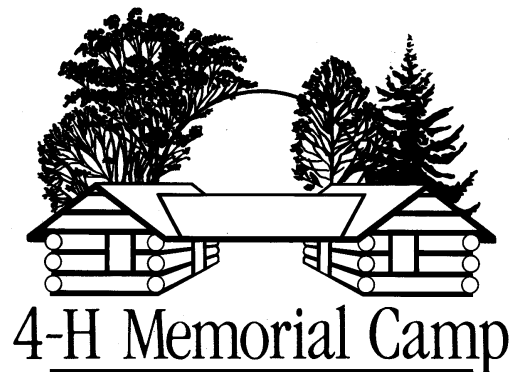
Purpose:

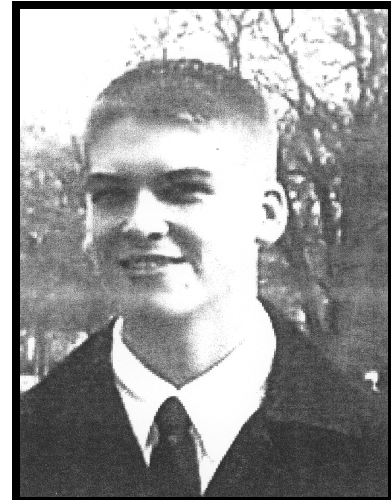
